

The registration process is not complete and no child can start camp until all the paperwork is completed and received by the JCC. This includes all emergency information, immunization documentation and financial arrangements. This information **MUST** be received before May 1st. _____ Initials

CAMP POLICIES As a parent/legal guardian of the camper indicated above, by registering I understand and agree to the following policies:

1. I understand that participating in any JCC activity involves the risk of accidental injury despite all safety precautions. Therefore, as a parent/guardian, I will assume all risk (injury or illness) for my children that may occur in any/all activities or use in/out of the JCC. In case of sudden illness or injury, I hereby give authority to any hospital, doctor, EMT or certified personnel to render immediate aid as may be required at the time for my child's health or safety. I understand that any and all medical or dental expenses are my responsibility. I acknowledge that I am aware of the potential risks of participating in activities and/or programs with the JCC and agree in no way to hold the management, agents, employees or board of directors of the JCC liable for any injury I or my child may sustain.
2. I understand that my child will need a signed permission slip for every outing outside the EVJCC. Without this, my child will not be able to attend the trip.
3. The State of Arizona licensing regulations requires each child to be signed in and out in a specific manner: first initial, last name COMPLETELY LEGIBLE. There will be a \$50 charge for any month that the requirements are not met IN FULL. Failure to fully comply for even one sign-in or sign-out will trigger this billing. This charge is for state compliance.
4. If your child is signed up for less than five days weekly, the days selected cannot be changed on a temporary or permanent basis during that week. (Example: If Mon, Wed, Fri are selected you cannot switch to Tues, Thurs, Fri.) This applies to Camp Rimon Katan ONLY!
5. Combination of grades depends on enrollment
6. I authorize JCC staff to apply sunscreen to my child.

PAYMENT

1. A non-refundable \$50 registration fee is required to insure your child a place in the camp.
2. Camp Gadol fees (school age) will be billed on May 5 (for pre camp and weeks 1-4) and June 5 (for weeks 5-9). Camp Katan (preschool) fees will be billed on May 15 (for pre-camp and weeks 1-4) and June 15 (for weeks 5-8 and post camp). You **MUST** have a credit/debit card on file with the EVJCC.
3. You may pay by check but your card on file will still be charged if you have not paid by the end of the billing day. Declined cards **WILL** be charged a \$20 fee.
4. Credits or refunds will not be given for ANY missed days (including sick and vacation days).
5. I understand that this agreement signifies a financial commitment for the weeks I register my child for the 2020 summer camp.
6. I understand that outstanding balances of 7 days or more may be subject to withdrawal of my child/children from programs unless alternative arrangements have been made with the accounting department.
7. Reentry into the program will require another registration fee.
8. Outstanding balances may be sent to outside sources for collection.
9. In the event of withdrawal from the program, I am still obligated to pay the remaining balance of my child's camp fees.
10. No refunds will be given for any reason after the billing dates.
11. There will be a 3% credit card processing fee added to ALL credit card charges.
12. Camp scholarships are available for families in need. Please note the deadline for applications is March 13, 2020; apply early as funds are limited. Financial awards decisions will be made by April 22. Scholarship applications are reviewed on a first come, first served basis.

If your child comes early or stays late, we can normally accommodate this. 24 hour written notice is required. You will be charged for added time at the rate of \$12 per hour. If less than 24 hours notice is given, you will be charged for added time at the rate of \$15 per hour. If you drop off more than 5 minutes early or pick up more than 5 minutes late you will be charged the minimum of \$12 per hour. **We do not prorate hours.** Our center closes at 6:00 pm. You will need to arrive by this time to pick up your child. At 6:01 pm, you will be charged at a rate of \$10 per minute. Please be respectful of our staff as they have worked all day.
