# TERMS & CONDITIONS

The registration process is complete, and my child can start camp ONLY when the East Valley JCC receives a completed registration packet. \_\_\_\_\_ INITIALS

# CAMP POLICIES:

- 1. We understand that participating in any EVJCC activity involves the risk of accidental injury despite all safety precautions. Therefore, as a parent/guardian, we will assume all risk (injury or illness) for our child that may occur in any/all activities or use in/out of the EVJCC. In case of sudden illness or injury, we hereby give authority to any hospital, doctor, EMT or certified personnel to render immediate aid as may be required at the time for our child's health or safety. We understand that any and all medical or dental expenses are our responsibility. We acknowledge that we are aware of the potential risks of participating in activities and/or programs with the EVJCC and agree in no way to hold the management, agents, employees, or board of directors of the EVJCC liable for any injury we or our child may sustain.
- 2. We understand that all parents/guardians will receive a code to access Remini for our child's camp group. W e will use this to sign in and out our child every day in attendance. Failure to do this could result in a \$50 charge for each instance the sign in/out process is not completed.
- 3. Combination of grades depends on enrollment.
- 4. We authorize EVJCC staff to apply sunscreen to our child if provided.
- 5. Each family will be assessed a \$30 security fee each month.

# **AM & PM CARE**

We understand that if we need to add time for our child, the EVJCC can normally accommodate this. 24-hour written notice is required, if possible. We will be charged for added time at the rate of \$15 per hour. If less than 24 hours' notice is given, we will be charged for added time at the rate of \$20 per hour. If we drop off more than 5 minutes early or pick up more than 5 minutes late, we will be charged the minimum of \$20 per hour. The EVJCC does not prorate hours. The EVJCC closes at 6:00 pm. We will need to arrive by this time to pick up our child. At 6:01 pm, we will be charged at a rate of \$15 per minute. We agree to be respectful of the EVJCC staff as they have worked all day.

### PAYMENT

### We understand the following:

- 1. This agreement signifies a financial commitment for the weeks we register our child for the 2024 summer camp.
- 2. In the event of withdrawal from the program, we are still obligated to pay the remaining balance of our child's camp fees.
- 3. No refunds will be given for any reason after the billing dates.
- 4. A non-refundable registration fee is required to insure our child a place in the camp.
- 5. Credits or refunds will not be given for ANY missed days (including sick, quarantine and vacation days).
- 6. Camp Rimon fees will be billed on May 3 (weeks 1-4) and June 3 (for weeks 5-9). We MUST have a credit/debit card on file with the EVJCC.
- 7. We may pay by check but our card on file will still be charged if we have not paid by the end of the billing day. Declined cards WILL be charged a \$20 fee.
- 8. We understand that outstanding balances of 7 days or more may be subject to withdrawal of our child from programs unless alternative arrangements have been made with the accounting department.
- 9. Reentry into the program will require another registration fee.
- 10. Outstanding balances may be sent to outside sources for collection.
- 11. There will be a 3.5% credit card processing fee added to ALL credit card charges.
- 12. Camp scholarships are available for families in need. We understand that the deadline for applications is March 28, 2024; We will need to apply early as funds are limited. Financial awards decisions will be made by April 30, 2024. Scholarship applications are reviewed on a first come, first served basis.
- 13. There is a fee of \$10 a month to offset the cost of the JCC Early Childhood App.
